## **Summary**

The Toyow Token is the native utility token of the Toyow platform, a tokenized Real-World Asset (RWA) platform that enables fractional ownership and trading of high-value RWAs. The token facilitates purchases, rewards, exclusive access, and preferential pricing, with plans to expand its utility across other platforms. Additionally, it incentivizes community growth and engagement.

The Toyow platform addresses key barriers in the Web 3 space-lack of knowledge, accessibility, ease of use, and trust-by offering a secure and user-friendly environment for tokenized RWA investments. Through strategic partnerships, the platform creates and supports fractional ownership, instant settlements, and complies with regulatory standards.

The global market for **RWAs** is ripe for tokenization. With multiple major financial institutions announcing plans to release tokenized offerings over the coming years, the adoption of this mechanism to improve value delivery systems is accelerating at a rapid pace.

The experienced leadership and advisory team at Toyow bring a wealth of expertise in blockchain, finance, and capital markets and Toyow plans to tap into this potential across multiple asset classes, including but not limited to art, music, real estate and classic cars.

## **Current Market Scenario of Tokenization**

Tokenization is gaining significant attention across various sectors, with a growing belief that it could democratize access to valuable assets by allowing fractional ownership. This trend is particularly strong in the entertainment and art industries, where assets like movie royalties, music rights, paintings, and other artworks are being tokenized, providing new avenues for monetization and investment.

Investors and corporates see Tokenization as a way to unlock liquidity in previously illiquid markets, giving a wider audience access to high-value assets. Private equity (PE) and venture capital (VC) firms view tokenization as an innovative avenue for investment, recognizing its potential to reshape traditional funding models in the entertainment industry. The shift in industry is visible already, as BlackRock announced its plan to tokenize USDIO trillion of its assets in March this year. Just this month, Janus Henderson also unveiled its intent to run its money market funds on blockchain.

These firms are increasingly interested in startups that utilize blockchain technology to enhance transparency, efficiency and security in transactions.

## Scope

The market for RWAs presents a compelling opportunity for tokenization and fractional ownership. Each asset class within our target markets has its own characteristics and growth potential. As per a <u>Forbes</u> study, despite an overall slowdown of Artwork sales in the global market, online sales increased by 7%, reaching <u>\$11.8 billion</u>, which is double what they were in 2019. Online art sales now account for <u>18%</u> of the art sector's profits worldwide. This shift towards digital platforms aligns perfectly with the Toyow tokenized marketplace model.

As per <u>Variety</u>, the global music market is growing, with recorded music revenues were up 10.2% in 2023 to USD 28.6 billion. This is the ninth year in a row of growth and the second highest growth rate since 2021. The 2023 total sales figure is the highest since 1999.

A significant percentage of these revenue cycles are expected to be tokenized over the next few years with Toyow positioning itself to be a market leader in this space.

There are multiple reports which project significant market share capture in the coming years.

A McKinsey <u>study</u> markets for tokenized assets are projected to reach a market cap nearing USD 4 Trillion in a conservative scenario by 2030, while BCG market research expects the tokenized market cap to reach between USD 16T to USD 64T by 2035.

## Challenges

Traditionally, high value assets such as Movies, Music, Artwork have been the exclusive investment domain of a few industry insiders and High Net worth Individuals (HNI's). Added to this, the Web 3 space is relatively new compared to many other industries which leads to a lack of knowledge, accessibility, ease of use, cost of transactions, trust and fractured liquidity amongst other key barriers.

Traditional settlement times can be a challenge, ranging from T+7 to T+14 days. Additionally, there are issues with the immovability of large assets, limited access to members-only clubs, and lengthy cross-border settlement times.

### What Toyow solves

At Toyow, we have successfully addressed these challenges by building a secure, compliant and user-friendly platform that democratizes ownership, where assets can be purchased using traditional FIAT or Crypto without needing to have expertise in either crypto or investment space at affordable price points.

Toyow through its partners curate's projects which allow fractional ownership, have affordable price points and allow instant settlements. All this is done along with ensuring adherence to relevant compliance requirements.

## The TOYOW Token

The TOYOW Token is the central utility token of the Toyow platform, facilitating transactions, incentivizing participation, and enabling community engagement. In the future it aims to become the native utility token to partners in the Toyow ecosystem.

The Toyow Token will be built on the Base protocol and will be made available on CEXs, DEXs as well as on the TOYOW token website.

Base is the layer 2 scaling solution developed by Coinbase. It is designed to bring in the next billion users into the blockchain ecosystem by offering a secure, low cost and builder friendly platform for Web 3 projects. It has the same security standards as it settles on the Ethereum mainnet.

## **Tokenomics**

#### **Total Supply and Minting**

#### Total Supply:

The total supply of the **TOYOW** Token is fixed and capped at 1 billion (1,000,000,000). The total number minted will never exceed this number.

**Circulating Supply:** The initial circulating supply will be strategically released based on community needs and project milestones and all emissions will be announced before time through various community and social channels, ensuring gradual and sustainable token distribution.

**Burn Mechanism:** To manage inflation and increase token scarcity, a token burn mechanism will be implemented based on revenue, community and operational discretion.

**Strategic Release:** Tokens allocated to the community and other categories will be released gradually over specified periods, aligned with project milestones to ensure demand and supply are balanced.

**Optimum Circulation:** To maintain liquidity and avoid market manipulation, token release schedules will be transparent and communicated to the community.

**Staking:** Token holders can earn additional perks, benefits and rewards by staking their tokens.

## How does the TOYOW Token derive its Value?

#### 1. Exclusive benefits

- Assets at discounted prices: TOYOW token holders will be able to purchase tokenized assets listed on the Toyow marketplace at discounted prices,
- Reduced fees: TOYOW token holders will have the advantage of reduced transaction fees while purchasing tokenized assets listed on the Toyow marketplace
- Upcoming Projects: Toyow has multiple upcoming projects valued at approximately USD 150 Mn which offers investors and fans an opportunity to participate in the entertainment industry through tokenized assets

#### 2. Buy & Burn

- This is designed to add value to the token by reducing its total circulating supply.
- 1.5% of the annually generated revenue from the marketplace will be allocated to buy back tokens from the open market.
- Approximately 85% of them will be burned, effectively removing them from circulation permanently.

By continuously reducing the supply while maintaining demand, the Buy & Burn mechanism is aimed at creating long-term value for token holders and strengthening the token's position in the market. This approach also serves to align the interests of the Toyow platform with its users, ensuring that as the platform grows, holders may benefit from potential price appreciation driven by the controlled reduction of supply.

#### 3. Staking

- As staked tokens are locked and cannot be traded during that time, it decreases circulating supply which creates deflationary pressure.
- It gives additional rewards and engagement for staked tokens.
- Staked token holders will get exclusive asset opportunities for rare collectibles

## Technology

#### 1. Protocol & Standard

We will mint the tokens using the ERC-20 standard on the Base Network, a secure and efficient layer-2 blockchain optimized for scalability and cost-efficiency. This protocol ensures compatibility with existing DeFi platforms, wallets, and exchanges, enabling seamless token transfer, usage, and integration across various ecosystems.

#### 2. Token Storage & Security

As the secure storage and management of tokens is paramount, the platform will implement industry-standard security protocols to protect user assets and maintain system integrity.

#### **Security Measures:**

- Encryption: All sensitive data, including private keys and transaction information, will be encrypted using advanced cryptographic techniques to prevent unauthorized access.
- Authentication: Multi-factor authentication (MFA) will be employed to add an extra layer of security, ensuring that only authorized users can access their accounts.
- Monitoring: Continuous monitoring systems will be in place to detect and respond to suspicious activities promptly, maintaining the integrity of user accounts.
- Compliance: The platform will adhere to relevant regulatory standards and best practices to ensure a secure and compliant environment for all users.
- Multisig Wallets: Will be used to store and transfer the tokens which may be 3/5 or 4/5.

By implementing these measures, the platform aims to provide a secure and userfriendly environment for token holders, safeguarding their assets and building trust within the community.

#### 3. Access to Wallets:

Users will interact with their custodial wallets through the platform's web or mobile interface.

APIs will be provided to check balances, transfer tokens, and view transaction histories.

- TOYOW Token adheres to all relevant regulations within the jurisdictions it operates, including AML and KYC protocols and other relevant jurisdictional compliances
- Regular audits of smart contracts and platform security
